MEET RULES AND INFORMATION

1. The competition is a Level 4 licensed meet, held under Swim England Laws and Regulations, Swim England Technical Rules of Racing and to the Swim England Open Meets licensing Criteria.
2. The competition is only open to members of Bushey Amateur Swimming Club.
3. The promoter is Kevin Binns on behalf of Bushey Amateur Swimming Club.
4. There is a single 200m IM event that is open to all age groups and forms part of the overall Club Championships 2019.
5. A trophy will be awarded to the fastest Male and fastest Female swimmer at the annual awards evening.
6. Age groups for Club Records are age on the date of the swim.
7. The pool is 25m and anti-wave devices will be in place.
8. Heats will be swum as mixed age with swimmers seeded by entry times.
9. Heats may be swum as mixed gender provided that there is at least one clear lane between swimmers of different gender.
10. Over the top starts may be used at the referee's discretion.
11. There are no minimum or maximum qualifying times for entry
12. Entries are free and must be submitted through the club website by the closing date.
13. Results will be published on the club website within one week of the event and will be supplied to British Swimming for entry into the national ranking database.
14. Anyone who wishes to take photographs or video at the meet must first sign the photography book at the entry desk. Anyone signing the book will be issued with a wrist band, which should be worn prominently. Any parents or carers of swimmers under the age of 18 who wish to take photographic or video images are requested to focus on their own child as much as reasonably possible and to avoid including other children in those images, particularly if those images are being shared with family and friends through social media platforms. Should you have any concerns about photography or filming at this event then please bring them to the attention of the promoter. Note that any photography in the changing rooms is absolutely forbidden by both the club and the swimming pool management. These rules on photography apply to swimmers, coaches, team managers, officials and volunteers as well as spectators, and to the use of mobile phones, tablets or other image-capturing electronic devices as well as cameras.
15. All participants must observe the safety precautions in operation at the venue. Neither the Promoter nor Bushey Amateur Swimming Club will be responsible for any loss or damage occurring during this meet.
16. The Data Protection Act 2018 requires us to provide you with certain information and to obtain your consent before processing data about you. Processing includes: obtaining, recording, holding, disclosing, destruction or retaining information. We require certain personal data for the purposes of making entries to the competition, managing the meet and the submission of results to Rankings. The information provided by you will be processed in accordance with the Data Protection Act 2018. Consent to process such personal data is

deemed to have been given by the submission of the entry. Where the personal data of competitors, officials and coaches/team managers has been passed to us by a third party such as a club rather than by the individuals themselves, we rely on the third party to ensure that consent has been obtained.

17. Any conditions not covered by the above will be at the discretion of the promoter and lead referee.
